- 1) Present this completed form (**ALL** spaces below **MUST** be filled in) along with a **non-refundable** fee of \$15.00 and all other required documentation to an EVHS parking lot attendant. Cash or check **ONLY**. **No** debit/credit. The non-refundable fee will reduce in January to \$10 and \$5 for the last nine weeks.
- 2) Required documentations are: a valid driver's license and current proof of insurance.
- 3) Affixing the parking permit to your vehicle (in the appropriate place) means you agree with the following policies.

POLICIES/RULES: (Repeated violations of the rules will result in loss of parking privileges without a refund.)

1. Permits and fees only apply to the current **2020-2021** school year and must be renewed annually.
2. Permits must be affixed to the lower corner on passenger side of the front windshield, be visible at all times, and **may only be used for the vehicle for which it was registered**. Permits may not be altered, copied, resold or given to another person; doing so will result in a loss of parking privileges and/or disciplinary actions. Temporary permits are available for emergency use only for students who have already purchased a current permit.
3. Students may only park in student designated areas. There is to be no parking in staff or visitor spaces, in the grass, on curbs or sidewalks, or in the front lots of the building. Violations and/or Referrals will be issued for wrongful parking. After 3 violations your vehicle will be booted and students will incur a Boot Removal Fee of \$25. The boot will remain on the vehicle until the fine has been satisfied and will only be removed during school hours. **Vehicles which are improperly parked and/or booted are subject to towing and will be done so at owner's expense.**
4. **Vehicles parked on school property are under the jurisdiction of the school. Searches of vehicles may be conducted any time there is reasonable suspicion to do so. Students are responsible for and subject to disciplinary actions for all prohibited items that are found in the vehicle. Students have full responsibility for the security of the vehicle and its contents. PLEASE** be sure to keep your vehicle locked at all times.
5. The school and/or the district are not liable for theft, vandalism, towing cost, or any damage to the vehicle while on campus or that may occur during towing.
6. **Parking privileges may be revoked for the following reasons:** over the limit speeding (**The maximum speed limit on campus is 15 mph**), reckless driving, truancy, disrespect to staff, leaving campus during the school day without authorization, assignment to GAP/JJAEP, or withdrawal from EVHS. **This list is not all-inclusive.** Administrators may revoke parking privileges any time it is deemed necessary.
7. Students must enter and exit the back parking lot on Patriot Way. **EVHS is not an open campus.** Students are NOT permitted to leave campus without Attendance Authorization through their guardian. Parking lot gates will be closed during the instructional day.
8. **Students are not allowed to access their vehicle during school hours without proper authorization.**
