



Student Guidelines

Georgetown ISD Bring Your Own Device (BYOD)

Student & Parent Instructions: Please review these guidelines.

Sign and return this page to your student's homeroom teacher.

1. Elementary students at participating schools and grade levels, middle school, and high school students are allowed to bring a personal mobile device to school after their campus BYOD start date. Students are NOT required to bring a personal mobile device to school.
2. The student and his/her parent/guardian must sign and return this form before the student may participate in BYOD.
3. Students may bring mobile devices including laptops, netbooks, tablets, smart phones, and eReaders. Handheld gaming devices and gaming consoles are not allowed.
4. Students who bring personal mobile devices should fully-charge the battery before bringing it to school each day. The student must take the personal mobile device home at the end of each day to recharge its battery and to keep the device safe.
5. Students are expected to know how to operate their personal mobile devices on their own. Georgetown ISD teachers, staff and Technology Department will not provide technical support or troubleshooting advice to students.
6. Students must use the Georgetown ISD student wireless network (WiFi) connection when accessing the Internet or online resources from a GISD campus. Students are not allowed to create or join unauthorized wireless or wired networks to bypass Georgetown ISD's filtered student wireless network. Students may connect **one** personal device to the GISD wireless network at a time.
7. Students may use personal mobile devices in class for educational purposes only when permission is granted by their classroom teacher. Each campus will designate whether personal mobile devices may be used at other times/locations (e.g. before school, after school, and during lunch). Students may not use personal mobile devices when the classroom has a short-term substitute.
8. When not in use, students' personal mobile devices should be silenced or turned off and be put away in a location designated by the classroom teacher.
9. Students must comply with the Georgetown ISD *Student Code of Conduct*, the *Technology Responsible Use Policy (RUP) for Students*, and the *Bring Your Own Device (BYOD) Student Guidelines* (this document) at all times. Violations may result in disciplinary action including referral to campus administration, the loss of network and/or wireless network privileges, confiscation of personal mobile device, and/or referral to law enforcement authorities.
10. Students may not use their personal mobile device inside or outside the classroom in a way that disrupts the educational environment, violates the rights of others, or invades the privacy of others, including but not limited to using the device to cheat, to violate school conduct rules, to harass or bully students or staff, or for unlawful purposes.
11. Before recording audio or video or taking a photograph, a student must obtain permission from a teacher or campus administrator and from the person being recorded or photographed. The student must obtain the same permission before publishing, posting, disseminating, sharing, or transferring audio/video recordings or photographs/images. Recordings and photographs are allowed only for a teacher-approved project or activity.
12. Students may not take, publish, post, disseminate, share or transfer audio, video, photographs, or images that reveal private parts of the body that are ordinarily covered by clothing. Students may not possess pornographic images or video on any electronic device.
13. Georgetown ISD is not responsible for theft, loss, or damage to a student's personal mobile device or to content on the device while at Georgetown ISD or connected to the Georgetown ISD network. Georgetown ISD is not liable for content already on the student's personal mobile device. Georgetown ISD is not responsible for any monetary charges that may occur while the student is using the device.
